

The GRP Meeting - Sandy would like to have the September meeting at the GRP and suggested September 5. This date was not received well, considering that OTR happens that weekend AND it's Labor Day weekend. Dana will discuss alternate dates with Sandy, including September 19.

WNS - the DUG EC recommends responsible caving when dealing with the WNS outbreak including gear decontamination and attention to cave surroundings. The DUG gear is again available for rental.

DUG Dues - research into the cost per person for a paper Carbide Courier was conducted. It costs \$7.50 per year per person to produce a paper Carbide Courier. Because of this, DUG Dues will go up by \$5 for those who elect to receive a hard-copy of the Carbide Courier, beginning this year.

The meeting was adjourned at 6:30pm.

MINUTES OF THE MAY 10, 2009 GENERAL MEMBERSHIP MEETING

The meeting began at 7pm. 17 people were in attendance.

In-attendance position reports are as follows:

Secretary - nothing.

Treasurer -

Checking: \$640.49 Savings: \$2082.99

The treasurer voiced concerns about our dwindling checking account and is looking at options for fundraising possibilities. Tailgaters offers an option to go eat/drink and 15 percent goes back to the organization. Also looking at other options for fundraisers, and will report back to the EC within the month.

Courier - Electronic edition for May is out. Hard copies will go out sometime this week. June edition in the works - send stuff by Memorial Day weekend.

Membership - 173 members.

Equipment - Rental had been temporarily suspended - will start back up again as of this meeting. Members renting the gear are required to decontaminate the gear properly after use.

Vertical - 5:30 at Happy Corners this Thursday. Let Tama know if you plan to attend.

Lunacy - Person (Colin) is here!!! Nothing except the presentation.

Great Saltpetre Preserve - Open House this coming weekend. Karst-o-Rama happens in June. Amendment to management plan is out regarding Bbanishment - now that the Rockcastle Karst Conservancy is responsible, this is needed. A written complaint needs to be submitted regarding occurrences. Text is on website and will possibly be in the newsletter. Work weekend happened this weekend. Meeting on the 12th at Molly Malone's @ 7pm.

Indiana Karst Conservancy - WNS is the big topic right now. All properties are open save for Grotto, Coon, & Robinson Ladder caves.

Richard Blenz Nature Preserve - Dispute with landowner over half the cave. No trespassing signs now up IN the cave. Owner does have pit entrance on his property and claims that he'll prosecute people in the cave under his property. Cave is officially owned by the NSS.

Kentucky Speleological Survey - Talked about how to handle WNS - if a valid request is filed, they'll release information. Otherwise, nothing special will happen voluntarily. Changes in bylaws also occurred with a quorum present.

White-Nose Syndrome – The EC's recommendations concerning WNS were covered: the DUG EC recommends responsible caving when dealing with the WNS outbreak including gear decontamination and attention to cave surroundings. The DUG gear is again available for rental.

Wormfest has been moved to Rocky Fork State Park on August 21-23. Primitive camping, shelter house, and showers are available at the site (Ed., this will be the first Wormfest held in Ohio).

Dues - Dues will go up for those wanting a paper Carbide Courier by \$5. If you get electronic, dues will go up by \$5 beginning now.

A 15 minute break was taken. Colin Gatland and Mike Lucas gave a presentation on the History of Mine Lighting.

Meeting was adjourned at 8:25pm.

UPDATE FROM THE ROCKCASTLE KARST CONSERVANCY CHAIRMAN

MISTY CAVE

May 15th - the opening date for Misty Cave is upon us. After much discussion, information searching, meetings, and comparison with other conservancies around us, we have decided to keep Misty Cave closed on a month to month basis, until a clearer picture of WNS emerges. Misty cave is an active and large hibernaculum and we do not want to take chances until we fully understand the risks. This is not an easy decision, nor was it unanimous. We are committed to continually assess current information and try to clear access as soon as possible.

However, PLEASE, don't let this keep you from donating to pay off the debt. The post-WNS caving world may look a lot different, and we may be depending more and more on our conservancies to secure access and permissions to cave. Paying off Misty as soon as possible allows RKC to grow and purchase more caves. Please give and continue to support Misty Cave, RKC, and Caving in general.

Dear IKC member,

As you likely know, White-Nose Syndrome is seriously impacting several species of bats in the east and is likely to spread as time goes on. It is too soon to tell how fast it will spread to major hibernacula in the Midwest, if an intervention can be formulated, or a natural response will slow or stop the disease. Regardless, federal and state agencies are reacting to the concerns. While some precautions and closures are warranted, some agencies are at a loss and are probably overreacting by closing down everything in an attempt to do something. It is too soon to judge if that is appropriate or necessary, but it is what it is.

The IKC, being an owner and manager of several caves, some purchased or managed for the protection of bats, while others focused on recreation or other resources, also needed to decide what is best for the bats in some situation, and what is reasonable for cavers in others. As such the IKC Board has been discussing and debating for over a month and have consulted with agencies and other land management organizations. With the winter closures at three of our caves ending May 1st, we wanted to have an appropriate decision for those caves and have it communicated to the various Grotto Liaisons (which we did last Friday). As such, the Board adopted the following policy:

"As a preventative measure for White-Nose Syndrome, the IKC will suspend 2009 summer visitation at Coon, Grotto, and Robinson Ladder caves except for approved scientific research. Access to other IKC managed caves will remain open with the added stipulation of practicing appropriate 'safe' cave gear/

clothing precautions."


So for the three bat caves, we have asked the Grotto Liaisons to suspend access for this summer (and I suspect this will be extended in the future). For the other caves owned or managed by the IKC, we think we are being responsible by simply asking all visitors to these caves to take precautions in making sure their gear and clothing are clean/decontaminated before visiting. This is especially true for any cavers who have caved in the 17 eastern states identified by the USFWS as being at potential risk for WNS. We hope to have more information posted on the IKC website soon, but there are already a number of good websites accessible from the NSS website on decontamination procedures and other recommendations to prevent transportation of fungus spores.

We don't anticipate any additional changes to our policies in the near future, but this whole WNS issue has been very dynamic, so it's difficult to predict the future.

date, location and topics that were to be discussed at the May E/C meeting. NO ONE that attended the meeting had problems with us raising the dues for people who receive a paper copy of the C/C. A vote of the 6 present E/C members was taken, and the proposal passed.

A DUG member then researched the by-laws and interpreted "Rule 2.a" as an improper assessment charge to the DUG members. Like this member, I am not an attorney and was not sure how the interpreted "Rule 2.a". So I got a professional review of Section 2 of the DUG by-laws. Listed in blue below is my lawyer's interpretation (see below).

"Dana.

Unless elsewhere in the rules it says that each member gets a free, paper copy of the newsletter, I don't see anything in here that would prohibit charging the \$5.00 to anyone who wants a hard copy sent to them. If the newsletter is sent electronically (which you said it was going to be), then I'd consider the five bucks as a voluntary contribution from anyone who requests a newsletter in paper-form, and the language below specifically states that voluntary contributions may be solicited for specific purposes. If someone doesn't want to pay it, then they only get the newsletter via email like everyone else...seems simple enough to me! Jana"

The DUG E/C is NOT violating the by-laws by charging \$5 to members who want a paper copy of the E/C. Starting 2010, DUG members who want a paper copy of the C/C mailed to them will be charged an additional \$5.

Prior to last weeks raise in postage it cost approximately \$7.50 to mail the C/C to each member. A new cost has not yet been figured, but rough math says its will cost DUG closer to \$9.00 per member for 2010. (That leaves less than half of your dues for the grotto to operated with and make donations.)

At one point someone stated they were upset that DUG was raising the dues so we had more money

to party with. That is another non-truth. Listed below is a list of the major expenses and events for the past couple year (please see below).

HUBER HEIGHTS KARST FEATURES Mike Hood

A year or so ago I received a call from someone who wanted to know if I knew about the caves that used to exist in Huber Heights. I told him I didn't and he then told me about stories his grandfather had told him about exploring small caves in Huber Heights when his grandfather was a boy (early 1920s). He said his grandfather told him they were covered over during the development of Huber Heights.

Fast-forward to May 2009. I received a call from Jerry Baker. He was intrigued about the stories of Joe Windows Kettering Cave and explained he is an avid mushroom hunter, as well as caver, and that he came across several small sinkholes and a rather large spring in Huber Heights while mushroom hunting.


He explained that while the sinkholes were small and did not contain any open passage, one did show some potential for open passage, though very small. However, he said some digging might actually open it up more. He also explained that all of the sinkholes channeled quite a lot of water into the ground after heavy rain.

Additionally, he said there was a large spring that was approximately 40 fee below the sinkhole plain and was in a direct line of the sinkholes. He was thinking there may be passage between the sinkholes and the spring.

We set a day for me to meet him so he could show me the sinkholes and spring. I will be writing the story about what we saw for the July edition of the *Carbide Courier*. Stay tuned...
